Implementation of the Electronic Government Procurement (e-GP) System in Sri Lanka

As you are aware, the Government of Sri Lanka launched its e- GP system in the year 2020 in order to achieve efficiency gains within a digitalized platform with enhanced transparency and accountability. As an initial step towards this end, procurements under National Shopping Procedure has been successfully launched.

- 02. In this backdrop, I wish to draw your kind attention to the Public Finance Circular No. 08/2019, dated 17.12.2019 on the Implementation of the Electronic Government Procurement (e-GP) System in Sri Lanka, and in terms of the Paragraph 2.5 of the above circular, all the Ministries, Provincial Councils, Departments / District Secretariats, State Corporations, Statutory Boards and State-Owned Enterprises have been directed to upload the details of procurements to the e-GP Portal at www.promise.lk by the Liaison Officers of the relevant procuring entities with effect from January 01, 2020.
- 03. However, it is regretted to note that most of the state agencies have not followed the above instructions and have failed to update this information to the e-GP Portal.
- 04. Given the highest importance attached by the government to create an efficient and transparent Government Procurement System in the country, you are kindly requested to instruct the relevant officials who are involved in procurement related activities directly comes under your purview to adhere to the following instructions:
 - a) Publication of Procurement Notices

Procurement notices relating to all methods and categories of procurements with an estimated value more than LKR 200 Mn are to be published in the e-GP Portal with effect from May 01, 2023, by registering under the e-GP Portal.

b) Information on Contract Awards

Details of awards of contracts with a value more than LKR 200 Mn are to be collected by the Line Ministries and to be submitted to the email address info@promise.lk. in the prescribed

form which is available at https://www.treasury.gov.lk/web/public-finance-department-circular/section/2023 (Annexure I).

Further, you may please note that from May 2023, appointment of Cabinet-Level Procurement Committees will be made only upon fulfillment of requirements set-out under (a) and (b) above.
