	Statute No. 02 of 2018 Pawnbrokers (Amendments) of the Southern Provincial Council
	BE it passed by the Provincial Council of the Southern Province of the Democratic Socialist Republic of Sri Lanka as follows:
Short Title.	01. This statute may be cited as the Pawnbrokers Statute (Amendment) No. 02 of 2018 of the Southern Province.
Amendment to the word consistence as inconsistence.	02. The word "consistence" depicted as "This Statute is consistence with the provisions of pawnbrokers Ordinance No. 13 of 1942" in the first page of the pawnbrokers Statute No. 01 of 2013 of the Southern Province shall be repealed and amended as "Inconsistence".
	03. The new section mentioned below is hereby included to the main statute and subsequent to thereof and the said section shall be come into force as II (I) of the main statute.
	II (I) An interest incurred in respect of the deposit of pawnbroker business if any, should be credited to the Provincial Council Fund.
in any inconsistency the Sinhala text to prevail text of this Statute.	04. In the event of any inconsistency between the Sinhala and Tamil texts of this statute, the Sinhala text shall prevail.
